**ISSUE OF AZUMAH RESOURCES LIMITED SHARES – SECONDARY TRADING NOTICE
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001
(Act)**

On 8 February 2016, Azumah Resources Limited (**Company**) issued 2,755,172 fully paid ordinary shares (deemed issue price \$0.0293) as consideration for interest due and payable in accordance with the terms and conditions of a Converting Note Agreement dated 24 January 2014 (**Securities**).

Secondary Trading Exemption

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.
