ISSUE OF AZUMAH RESOURCES LIMITED SHARES – SECONDARY TRADING NOTICE NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Act)

On 9 May 2018, Azumah Resources Limited (**Company**) issued 909,090 fully paid ordinary shares at an issue price of \$0.022 per share (**Securities**).

Secondary Trading Exemption
